# <u>SECTION 1</u> CHARGES AGAISST SHIPOWNERS OR SHIPS' AGENTS (VAT EXCLUDED)

# 101. PORT DUES

Use of channel, navigation aids, and other facilities to ensure safety in entering and leaving Port Area including cost for use of line handling boat and line handling service to/from Berth for vessels larger than 700 GRT.

Rates for 1 trip will be charged when entering port as follows

### 102. TUG SERVICES

Use of tug boat for servicing vessel. Charges are made according to the size of vessel as follows:

STAND – BY: Service charges shall be made according to the size of vessel as follows:

### TIME COUNTING.

Service charges are assessed from the time that the tug boat leaves from the station to the time it returns. The minimum charges shall be 2 hours per tug per movement. In case of time using tug boat less than 30 minutes, the charges will be counted as half an hour per tug. But if the time using more than 30 minute, the charges will be counted as one hour.

### THE POSTPONING OR CANCELING OF TUG SERVICE

Shall be notified during working hours but not late than 3 hours in advance.

Otherwise, the vessel will be charged for a minimum service charge of 1 hour per tug.

### **TUGGING OR TOWING**

Outside the port territory shall be considered in advance case by case.

### 2. ROPE BOAT SERVICE

The minimum charges shall be 1,500 baht per movement. At least 2 hours' notice must be given to cancel, stand – by or postpone tug service, otherwise vessel will be charges for the additional of 750 baht /movement.

### 3. PILOT & SURVEY BOAT / SERVICE BOAT.

The minimum charges shall be 3,000 baht per hour. The minimum time counting will be one hour.

### 4. LINE HANDLING GANG

The minimum charges shall be 4,000 baht per movement. At least two hours' notice must be given to cancel or postpone tug service, otherwise vessel will be charges for the additional of 1,000 baht / movement.

# 103. BERTH HIRE

Use of berthing place for vessel. Charges are made according to berthing place and calculated per hour as follows:

BERTH HIRE	Baht/100GRT/Hour
103.1 AT Multipurpose Terminal	7.5
103.2 At Harbor craft berth	5.0

# 104. BERTH HIRE OF OTHER CRAFT

Use of Berth for other types of craft. Charge are calculated per day commencing from the hour of berthing as follows:

104.1 At berth or beside vessel at Berth	1
104.2 Minimum rate for Berth Hire of Other Craft	750

### 105. CARGO WHARFAGE

Use of Berthing Area and labor for stevedoring cargo to or from vessel. The charges also include moving cargo to or from yard.

Cargo wharfage at Anchor Area does not include labor for stevedoring.

Charges are based on amount of cargo as follows:

In case of storage at Storage Area, exemption period is 15 days after the completion date of unloading from vessel. If the cargo however has not been loaded to vessel during the allowed exemption period, the rule of item No. 204.1 will be applicable to that cargo relative to the exemption period (which will be reduced to 3 days or 1 day, as applicable) and relative to the charges.

### 106.GARBAGE CHARGES

For garbage collecting services from all vessels. Charges are calculated per day commencing from the hour of berthing as follows:

### 107. TELEPHONE SERVICE OO BOARD

Use of telephone on board of vessel at Berth for communications inside the Port on request of Ship owner or Agent.

Charges are per day

300 Bath/Phone/Day

In case of use of telephone for communications outside the Port, additional charges will be at the same rate as by the Telephone Authority of Thailand.

### 108. WATER SUPPLY SEVICES

Charge are

25 Bath/Cubic/Meter

Minimum charge of fresh water supply is 50 cubic meters.

# 109. LABOUR STAND BY CHARGE

Charge for waiting time in case of Ship owner or Agent gave notice for loading/unloading general cargo or containers or for stuffing/unsnuffing loose LCL and operation cannot be continued for more than 1 hour for any reasons and which is not the responsibility of the Port.

Charge are

2,000 Bath/Event

### 110. PASSENGER FEE

Fee for passenger entering or leaving at Berth.

Charges are

30 Bath/Person/Passage

### 111. QUAY CLEANING CHARGE

Charge for cleaning Berth which are calculated per day commencing from the hour of berthing 300 Bath/Vessel/Day
